## BREEDING CONTRACT For AI: Fresh or Chilled Semen

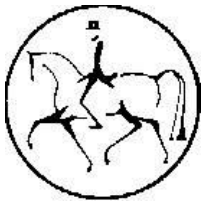

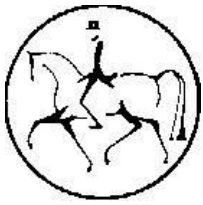
1. The service fee of the stallion is \$1,760.00 (inclusive of GST) - Somerset D'Isle and \$1,540.00 (inclusive of GST) - Isle of Aintree, Isle of Ascot, Isle of Hemingway and Isle of Lamborghini, which is to be paid in full at the time of the signing of this contract and is non-refundable.
2. FR denotes 'Free Return'. This relates to cases whereby the mare does not fall pregnant this season, absorbs the pregnancy and hence does not produce a foal from this season. It allows the mare owner or their agent the chance to use semen from the said stallion for the said mare next season without repaying the service fee. A handling fee will apply.
3. Live foal guarantee. It is our desire to provide mare owners or their agents with a live foal. In cases where the mare failed to produce a foal which stood and suckled for a period of 48 hours after birth (live foal) a Free Return will be provided to the said mare by the said stallion, the following season. This is contingent upon a veterinary report being received and that the stud is notified immediately.

4. All veterinary charges associated with the collection of semen will be borne by the mare owner or their agent and will be invoiced directly to the mare owner or their agent.
5. The chilled semen supplied is for use on the said mare only. Any unused semen must be discarded by the attending veterinarian or AI technician.
6. Delivery and postage fees for semen must be paid prior to dispatch. Please enquire for delivery fees as these will vary with destination.
7. The Stud may refuse to inseminate the Mare if;
  - a. The Mare poses an unacceptable danger to herself, her handlers or the Stud's property (including but not limited to the Stallion),
  - b. The Mare is unsuitable for breeding, as determined by the Stud in its absolute discretion,
  - c. The Mare owner or their agent does not fulfill any of the conditions referred to in clause 8.
8. The Mare owner or their agent must ensure (and provide evidence to the Stud if requested) that on arrival at the Stud, the Mare will be;
  - a. Halter broken and able to be led and tied;
  - b. Currently vaccinated for tetanus and strangles
  - c. Unshod;
  - d. Free of illness and disease (results of uterine swab must be provided to ensure the Mare is free of infection)
  - e. Free of injury unless prior notification has been received.
9. It is the responsibility of the mare owner or their agent, to ensure that the mare is scanned at 14 days after service and 45 days subsequently and that the results of these scans, which must be signed by the attending veterinarian, must be forwarded to the Stud within 50 days of the last service date. Results forwarded after 50 days may deny the mare owner or their agent a Free Return. A Service Certificate cannot be issued without documentation of proof of service, signed by the attending veterinarian.
10. The mare owner or their agent shall request semen from the stud 2 (two) weeks prior to service and must phone the Stud on the first day of heat then again the morning prior to the day of collection.

11. In the event that a Stallion dies or is rendered unfit for service, a refund will not be provided, however the Stud will provide a service to one of the other exceptional Stallions owned by the Stud, at the same cost.
12. If an agent is completing this application on behalf of an owner who subsequently defaults on payment, the agent is liable for all outstanding costs.
13. The Stud will take all reasonable care, but shall not be liable to the Mare owner or their agent in the event of the death of the Mare (and/or foal at foot), or in the event of the same receiving any type of injury or suffering any illnesses, howsoever arising.

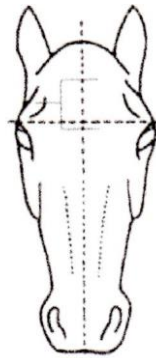
Forelegs – rear view

Hind legs – rear view

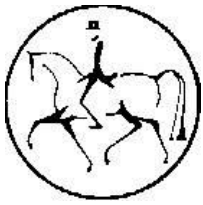
